# New Notice on COVID-19 Reinforcement Measures Restricting Movement and Gatherings

On 23 December 2020, the Prime Minister's Office issued the Notice on Reinforcement Measures for Containment, Prevention and Full Response to the COVID-19 Pandemic ("**Notice**"). The Notice follows the Decree of Prime Minister No. 93/PM dated 3 March 2017, the Order of the Prime Minister No. 06/PM dated 29 March 2020 which is referred to in the Notice, the report of the National Task Force Committee for Prevention and Control of COVID-19 ("**Task Force**") and the instruction of Prime Minister in the Meeting with the Task Force held on 22 December 2020.

The Notice sets out the following restrictions on movement and gatherings which must be implemented during the period from 23 December 2020 to 31 January 2021 to contain the COVID-19 pandemic in Lao PDR:

- International charter flights will be temporarily suspended from the countries with community outbreak of COVID-19, except for emergency flights and those that are necessary, which will be subject to strict monitoring and checking for compliance with safety measures. Passengers from countries with no community outbreak of COVID-19 will be tested for COVID-19. Passengers who transit from countries with community outbreak of COVID-19 shall not be allowed to take such flights.
- 2. The issuance of tourist and visit visas to individuals who travel from or transit through countries with community outbreak of COVID-19 will continue to be suspended, except with respect to tourists in group tours authorised by the Task Force. Diplomats, staff members of international organisations, experts, investors, business travelers, technicians and foreign laborers who need to enter into Lao PDR to carry out their diplomatic and international duties, business activities or project works may do so with prior approval/consent of the Task Force. Before the Task Force approves their entry into Lao PDR, they must hold a COVID-19 testing certificate via PCR device at least 72 hours before boarding. They must also undertake to undergo self-quarantine for 14 days upon arrival in Lao PDR.
- 3. All customary and local border checkpoints for entry and exit of individuals and goods will remain closed, except for customary and local border checkpoints authorised by the government for the transportation of goods to and from Lao PDR, which shall be sprayed with disinfectant in accordance with the technical determination issued by the relevant departments/agencies.
- 4. International border checkpoints remain closed for entry and exit of individuals, except for Lao citizens and foreigners who urgently need to enter or exit Lao PDR. Such entry or exit must be



approved by the Task Force. The transportation of goods through international checkpoint (i.e. entry-exit) may be done in accordance with normal procedures.

- 5. Concerts, nightclubs, and New Year celebrations are not allowed to be held outside of individual residences. It is highly recommended that celebrations, such as New Year, should be held at ones' own house. Regarding the Over-year Buddha Praying Ceremony, if it shall be held, it must be in strict compliance with the instruction of the Task Force. Wedding ceremonies may also be approved provided they are held in small numbers and conducted following Lao tradition and cultures.
- 6. The Government will continue to increase the dissemination of information even though Lao PDR has not had any COVID-19 outbreaks, as the neighboring countries and many countries around the world are now facing severe outbreaks. For this reason, Lao citizens and foreigners who are residing in Lao PDR shall take on enhanced responsibilities and implement the measures to prevent, control, contain, and respond to the COVID-19 pandemic (for the period of 23 December 2020 31 January 2021).
- 7. The Ministry of National Defense, Ministry of Public Security and relevant departments/agencies shall carry out strict inspections at the borders of Lao PDR in order to prevent illegal immigrants from entering into or exiting Lao PDR. This is to ensure that there is no risk of bringing any pathogen into the country.
- 8. Employees of all relevant local department/agencies in each level shall carry out strict inspections in their respective areas of responsibility to contain the COVID-19 pandemic in Lao PDR, and report COVID-19 cases to their superiors regularly and in a timely manner.
- 9. All travelers/commuters entering Lao PDR shall use medical monitoring devices which are able to monitor the movement and activities of such individuals. The Task Force shall be in charge of researching the rules and regulations and calculating the costs and expenses of the aforementioned medical monitoring devices as reference for actual implementation.
- 10. The Task Force shall enhance and refurbish the existing quarantine areas, whether in central or local areas, as well as add new quarantine areas, for use for isolating and treating the infected in the event of large numbers of people entering Lao PDR, especially Lao laborers departing from foreign countries and returning to Lao PDR.
- 11. The Task Force shall instruct the relevant departments/agencies and local administrations to increase strict monitoring and inspection of the quarantine areas relating to the compliance measures issued by the Task Force. Violations of the prohibitions shall be dealt with by the Task Force strictly.
- 12. The Task Force shall set out in detail the COVID-19 insurance requirements for foreigners entering Lao PDR.



13. The Task Force shall continue to liaise with neighboring countries and International Organizations to monitor and research into vaccines to prevent COVID-19 as currently, such vaccines are under trial for use in Lao PDR. It is anticipated that such vaccines shall be made available for use as soon as possible. The Task Force shall create provisions and plans to use such vaccines on the general population.


