### Supreme Court Seeks to Modernise the Rules of Criminal Procedure

More than two decades since the Rules of Criminal Procedure ("Rules") were last amended, the Supreme Court is revisiting the Rules through the CrimPro Revision Project to streamline criminal court processes and current procedures, integrating relevant case doctrines and other procedural rules that developed over time. This reexamination of, and amendments to, the rules of criminal procedure ("Proposed Rules"), spearheaded by Supreme Court Associate Justice Rodil V. Zalameda, is in line with the Court's 2022-2027 Strategic Plan for Judicial Innovations.

At present, there are various sets of procedural rules for criminal cases, such as the *Revised Guidelines* for Continuous Trial of Criminal Cases, the Rule on Cybercrime Warrants, and the Rule on the Use of Body-Worn Cameras in the Execution of Warrants. The primary objective of the Proposed Rules is to codify and institutionalise a comprehensive framework encompassing all relevant rules and procedures for the adjudication of such matters. The harmonisation of these procedural rules is anticipated to facilitate more efficient, effective, and streamlined judicial processes.

Among others, the Proposed Rules will address the conflicting provisions between Rule 112 of the current Rules and the Department Circular issued by the Department of Justice regarding the rules on preliminary investigations and inquest proceedings.

Through the Proposed Rules, the Supreme Court affirms that the justice system should adapt to the modern technicalities of the current time, not only to guarantee a more just and equitable outcome, but also to maintain public trust and confidence in the judicial process.


